## EDITORIAL

## NEW WATER JPI LOGO AND WEBPAGE

The month of July saw intense developments in corporate image and external communications. Our Italian partner ISPRA led this process, which resulted in the following Water JPI logo being approved by our partnership:



By the end of July, the first version of our webpage was published at: [www.waterjpi.eu](http://www.waterjpi.eu). This is a major achievement, signalling our will to reach out to the European Research and Innovation Community. ## PROGRESS IN WATEUR

There has been not much rest this summer at the Water JPI. Negotiations for [WatEUR](#) (the FP7 Coordination and Support action for



the Water JPI) were successfully completed, and the Grant Agreement is now finalising the signature process. We are now getting ready for an energetic start on January 1<sup>st</sup>, 2013.

## WATER JPI AT ESOF 2012

The European Science Open Forum was held in Dublin last July 11-15. On July 11 the water JPI organized the [session](#) "Water Challenges for a Changing World". This 90 minute event presented a broad view of water challenges, with presentations from key speakers from industry, the European Commission, Academia and Governmental Agencies. In the picture below, from left to right, Durk Krol (WssTP), Luisa Prista (European Commission), Michael Depledge (European Centre for Environment and Human Health), Damià Barceló (ICRA) and Laura Burke (Environmental Protection Agency, Ireland). Four of these speakers make part of the Water JPI governance.



## THE EIP ON WATER

The European Commission nominated Ms. Carmen Vela, Secretary of State of Research, Development and Innovation, Government of Spain, as member of the High Level Steering Group. Enrique Playán, Water JPI coordinator, was appointed to the Task Force. These bodies met on September 4 and 25, respectively. As a conclusion of both meetings, eight priorities



have been identified for the [EIP](#), covering a variety of aspects. The titles for these priorities are currently being finalised. Each priority addresses the urban, rural and industrial environments and explores the connections between these.

Selected priorities will be the basis for EIP activities in 2013. One of such activities is the FP7 call on “Water innovation demonstration projects”.

The task Force will elaborate a Strategic Implementation Plan (SIP) for the EIP on Water, containing a characterization of these priorities. The SIP will be approved by the High Level Steering Group before the end of 2012. The Water JPI will interact with the drafting of the SIP.

### **JPIs TO Co-WORK WORKSHOPS**

This FP7 Coordination and Support Action  [JPIs TO CO WORK](#) aims at providing support to the development of all ten JPIs. On September 20 and 21 a workshop was organized in Vienna to discuss Forward Looking activities and Ex-ante evaluation. Representatives from all JPIs attended the meeting, including four partners of the Water JPI. Stay tuned to the project [webpage](#) for more workshops.



### **UPCOMING JPI MEETINGS**

#### **Meetings in October 2012**

A two-day Water JPI meeting will be held on October 16 and 17 in Rome. The meeting will focus on warming-up **WatEUR** in anticipation of its kick off early in 2013. Work package and Task leaders will present detailed plans. The fourth meeting of the Water JPI Executive Board will be held in the afternoon of October 17<sup>th</sup>.

### **Meetings in February 2013**

Another two-day meeting will be held on February 5 and 6, 2013. This mega meeting will contain the second meeting of the Scientific and Technological Board and the Stakeholders Advisory Group, the fifth meeting of the Executive Board, and the WatEUR kick-off, counting on the presence of the whole Water JPI community.


### **FOOD FOR THOUGHTS**
