

- Review of the various water-related policy developments

# THE KEY STEPS IN THE PROCESS INVOLVES



What is it about?

#### The Water JPI Vision document

- Revision of the Water JPI Mission Statement
- Review of the key Research Themes
- Review of the Indicators to measure progress towards achieving the Vision 2030.



The Strategic Research and Innovation Agenda (SRIA)

- Based on the new revised key research themes
- Identify the subthemes and key knowledge gaps to achieve the mission of the Water JPI by 2030.



#### THE PROCESS

# Consultative process which has been broken down in six stages;

- Stage 1. Literature foresight review
- Stage 2. Public Consultation (online survey)
- Stage 3. Series of National workshops for key National stakeholders
- Stage 4. Series of semi-structured interviews
- Stage 5. Consultative workshop with Water JPI Governing Board and Advisory Board
- Stage 6. Experts stakeholder workshop



## STAGE 1; REVIEW OF STRATEGIC AND FORESIGHT DOCUMENTS

- Literature review of strategic and foresight documents
- Research priorities were categorised
- Information gathered used to inform Vision 2030 and SRIA 3.0 Recurring thread (another word)
- Inclusivity of all societies to clean safe water
- Impacts of globalisation/urbanisation
- Value of water and the "hydro-politics"

### **STAGE 2; PUBLIC CONSULTATION**

- Online Survey as part of the public consultation process
- Total 481 responses were received
- Information collated-feed into Vision 2030 and SRIA 3.0



## STAGE 3; NATIONAL CONSULTATION WORKSHOPS

Seven countries held national consultation workshops identify the national perspectives on the key changes that need to be made to the Vision 2030 and SRIA 3.0.

Additionally, European Research Network (ARC: Aqua Research Collaboration) also held a workshop with its members

## STAGE 4; SEMI-STRUCTURED INTERVIEWS


- Collect the perspective of a wider range of key stakeholders and Water JPI Partner countries
- Ensure that all Water JPI

  SRIA and Vision 2030
- Key stakeholders identified at Governing Board & Advisory Boards Consultative workshop

### STAGE 5; CONSULTATION WITH WATER JPI **GOVERNING & ADVISORY BOARDS**

Consultative Workshop for the Water JPI Governing and Advisory Boards (composed of the Stakeholders Advisory Group (SAG) and Science & Technological Board (STB))

#### **Workshop Objectives**

- What the Water JPI Vision up to 2030 could be and which themes should be considered;
- What indicators could be used in the Vision.
- New key scientific themes identified




## STAGE 6; EXPERTS STAKEHOLDERS WORKSHOP

#### **Objectives**

- Inform the drafting of the SRIA 2025;
- Collate information and feedback on the proposed RDI priorities (high-level) under each of the new proposed themes;
- Identify what may be missing;
- Identify what may still be valid from the current SRIA;
- Discuss expected impacts & indicators;
- Review research infrastructure needs/gaps.
