EDITORIAL

The CSA proposal continues its preparation. Twelve Water JPI partner countries have teamed up to participate in WatEUR

"Tackling EUropean Water Challenges".

The proposal has identified six work packages covering the main areas of the Water JPI. Proposal design aims at providing support to Water JPI implementation. The deadline of March 20th means that JPI partners will be quite busy in the weeks ahead. Now, for the good news, the proposal contains a detailed planning of most Water JPI activities for the period 2013-2015.

THIRD MEETING OF THE EXECUTIVE BOARD

Water JPI partners will meet at The Hague in March 1st. The meeting will review progress in WatEUR preparations. It will also prepare the enlargement of the Advisory Boards,

which will be performed at the second meeting of the Governing Board (May, 2012). New members will be selected from a list of candidates:

- The Scientific and Technological Board (STB) was requested last year to nominate twelve world-class STB candidates. Work is in progress.
- Partner countries are currently nominating candidates for the Stakeholders Advisory Board (SAG), focusing on prominent European organizations.

The Executive Board will also analyse progress towards a Strategic Research and Innovation Agenda, resulting from the input received this month from the STB and the SAG.



Candidate EIP on Water

The Candidate European Innovation Partnership (EIP) on Water continues its development. In February 1st the EIP will be celebrating a Stakeholder Consultation in Brussels. The event will gather an audience composed by research, development and innovation programme owners and managers, Industry, Academia, Innovation Agents and Government Officers. Discussion will focus on:

- The optimal governance model for the EIP on Water;
- The specific targets of the EIP on Water;
- Priorities of different work packages (rural areas, urban areas and industry; and
- Horizontal themes in the EIP on Water.

The Water JPI will be there, and will continue to cooperate in the building of this new initiative.

UPCOMING EXTERNAL EVENTS

Cooperation with FACCE JPI

The Water JPI will cooperate with the Food, Agriculture and Climate Change JPI ([FACCE](#)) during their meeting in Madrid in February 22 and 23. The meeting will be devoted to mapping activities, and will count on a presentation by the Water JPI.

World Water Forum
